# Project Management for Archival Processing, Tuesday, June 18, 2013

**Instructor:** Vincent Novara **Cost:** \$105 (includes lunch)

**Description:** This workshop focuses on introductory techniques and common tools for project management. Workshop participants will learn how to establish, define, plan, implement, and execute archival projects. Attention is given to strengthening prioritization skills and workflow planning as they pertain to processing projects executed by various levels of staffing, including the lone arranger. The workshop also addresses interpretive projects such as exhibitions and digital initiatives. Attendees will learn how to determine project goals and objectives, compose project objective statements, establish work breakdown structures, estimate project budgets, create project and communication plans, schedule and track tasks using Gantt Charts, and conduct a post-project evaluation. Throughout the workshop, standard project management terminology is applied to common archives tasks, and an overview is given of Earned Value Assessment.

## Copyright Fundamentals for Archivists and Librarians

**Thursday Fall 2013**

**Instructor:** Peter Hirtle, Cornell University Library

**Description:** Even in the best of times, the uncertain copyright status of archival and special collection materials makes many archivists and librarians uncomfortable. As more and more repositories think about making material available on the web, anxiety about possible copyright infringement increases. This workshop will explore what strategies special collections can follow to minimize the risks inherent when reproducing and distributing unique and/or unpublished material. Topics covered will include an introduction to basic copyright law and the Digital Millennium Copyright Act; exemptions to copyright such as fair use and the specific exemptions for libraries and archives; methods for assessing the copyright status of materials; and issues associated with particular formats. Attendees should leave with a better understanding of the basics of copyright and be in a better position to work with senior administrators to establish a mutually acceptable level of institutional risk.

#### **Other Comments:**

As stated in the previous report (February 2013), we ran into significant difficulties finding more than one candidate for Chair. We solicited suggestions and nominations through email, Facebook, Twitter, the MARAC blog, and in person from people we thought would make great chairs. We followed up on every name and reached out to at least eighteen individuals (and many more informally), with only one interested party.

NEC discussed the problem while we were trying to solicit candidates and we had a number of thoughts/suggestions/comments that might be useful in future discussion. I've included some of that conversation, direct from emails, below.

## Comment #1

Would it be helpful to add another Vice-Chair position? Mary Mannix has the Vice-Chair position wrapped up for as long as she wants it, I think. Since Mary focuses on the conferences, locations, etc., would adding a Vice-Chair position that mirrors what the Chair does be helpful in getting more interest in the position? A lot of boards have the Vice-Chair slide right in to the Chair position, so the focus isn't finding a Chair, it's finding the next Vice-Chair.

The few people I approached about running for Chair told me that they "weren't ready yet" or "wanted a couple more years to get to know MARAC," I couldn't fault their reasoning. Finding candidates for Chair has been a problem for quite awhile, right? Maybe having the comfort level of not jumping right into Chair would provide MARAC/N&E's more options for candidates.

## Comment #2

I know we always want multiple candidates for each slot but occasionally circumstances prevent this, and considering how many attempts we made I'm fairly certain we did our due diligence. That being said, I'm all for getting more folks interested in participating, and you're right that some positions are just more difficult to fill.

As long as we're throwing out ideas, why not familiarize members with what Steering and the various Committees do through MAA articles, blog posts, or conference sessions and introductions; preferably on an ongoing basis -- it's not difficult to shoehorn brief descriptions into MAA articles; e.g., "Regarding the upcoming conference, the Vice Chair worked with Local Arrangements to..." I know collections people don't like the spotlight but we could do more to recognize everyone's work.

#### Comment #3

Also, continually recruiting new faces for committees and less intimidating positions and then keeping tabs on outgoing members to gauge interest in higher level posts, realizing they may need a year or two off. The N&E handbook is good at keeping lists of prior office holders, there have to be individuals who served on Steering that would make good Chairs, Vice Chairs, etc. if given a push.

As a follow up to #3, I am updated the list of potentially interested parties that I received as nominations and the elections process progress and will pass it along to my successor. Personally, I've enjoyed this foray into MARAC service, despite some of the challenges, and I look forward to serving again in the future.
